The DRMS transmitted its adequacy response for the Bowie No. 2 Mine via email dated January 3, 2025. On behalf of Bowie Resources, LLC following are its responses to the DRMS's comments and concerns.

1. **DRMS:** On Map-01 it appears that there is no parcel for landowners Leonard and Dinah Wiggins (#05 in the landowner key) on the map. **Please explain why they are listed in the key if they do not own land in the permit area. Also, please check for other inconsistencies between map and the key and revise as necessary.**

BRL: Leonard and Dinah Wiggins purchased a small piece of land that was previously owned by Wagner Equipment. This piece of land is not within the permit boundary and will be removed from **Map-01** and **page 2.03-4**.

2. **DRMS:** It appears that the issue with access agreements was not addressed with the MR-208 application. BRL should state if new agreements were needed and provide them as a revision to the PAP (e.g., Exhibit 25 of Volume IIIB), as necessary in your response to this adequacy letter.

BRL: No new access agreements are necessary.
