The Colorado Division of Reclamation, Mining and Safety (“DRMS” or “Division”) has completed its review of the revised application materials that were submitted on December 27, 2024, and deemed the information adequate.

In reviewing the materials submitted, the Division has determined that the reclamation liability for the project to be \$70,640. The Division currently holds a financial warranty in the amount of \$2,090. An additional bond amount of **\$68,550** must be posted prior to the Division accepting your Notice of Intent to Conduct Mineral Prospecting. Please submit a financial warranty in this amount by **January 20, 2025**. If you need additional time to submit the financial warranty, please request an extension.

Please note that prospecting operations may not commence until the NOI has been approved by the Division and the BLM has also authorized the operation.
