Dear Craig Rasmuson:

On November 6, 2024, the Division of Reclamation, Mining and Safety (“Division” or “Office”) received your request for Amendment of 112c Construction Materials Reclamation Permit Application Package (AM-1) for the Korwell Dirt, File No. M-2022-034. The Division sent a Notice of Incompleteness letter on November 21, 2024 and on December 12, 2024, the Division received a response submitted by Korwell Land Holdings, LLC. A review of the information received determined that the following information must be received before the Division can consider your application as being submitted and technical review can begin. Thus, your application is incomplete for the purposes of filing as of January 14, 2025.

**Application Form:**

1. On Page 8, the Applicant indicated “Korwell Dirt Project” in the Applicant/Operator or Company Name section of the application form. Please revise the Company Name in the notary section of the application form to indicate “Korwell Land Holdings, LLC”. Also, please affix a corporate seal or write “no seal”.

**Exhibit R: Proof of Filing with County Clerk and Recorder:**

2. In accordance with Rule 6.4.18, please submit an Exhibit R that includes an affidavit or receipt indicating the date on which the amendment application was placed with the Weld County Clerk and Recorder for public review, pursuant to Rule 1.6.2(1)(c). To comply with Rule 6.4.18, please submit an affidavit or receipt indicating the date on which the amendment application was placed with the Weld County Clerk and Recorder.
  - a. The Weld County Clerk and Recorder is a separate entity than the Weld County Commissioners. You may submit the amendment application (including the requested revisions on Page 8 of the application) to the Weld County Clerk and Recorder at the address of:

You have until **January 20, 2025**, to submit all necessary documents that the Division needs for the application to be considered filed. If, by the above date, the application has not been determined to be complete and filed, the Division may deny the application and terminate the application file.

This letter shall not be construed to mean that there are no other technical deficiencies in your application. The Division will review your application to determine whether it is adequate to meet the requirements of the Act after submittal of all required items.
