14 holes were drilled, plugged with sodium bentonite grout, capped with 3/8" bentonite chip to 5ft bgs, and backfilled with native materials to the top of collar. The sumps were backfilled and compacted. The drilling pads surfaces were returned to original contour, topsoiled evenly, and reseeded via drill overland drill.
