Mr. Stockebrand:

On January 28, 2025, the Division of Reclamation, Mining and Safety (Division/DRMS) increased the required surety for this permit to \$25,843 in accordance with Rule 4.2.1. This increase in required surety is based on the September 2024 Inspection. The Division currently holds a Financial Warranty in the amount of \$12,914. Therefore, the resultant surety increase amount is \$12,929.

On this date, the Division orders amendment of the current financial warranty or submittal of a new financial warranty reflecting the surety increase within 60 days from January 31, 2025.
