Dear Aaron Gebauer:

On February 3, 2025 the Division of Reclamation, Mining and Safety increased the current Financial Warranty for this permit to \$46,688.00, in accordance with Rule 4.2.1 of the Rules and Regulations. This is an increase of \$20,188.00.

During a recent inspection of the CLG Farms, LLC Pit, it has come to the Division's attention that the bond for this site has not been updated in a significant amount of time. Per Rule 4.2.1, the Division is required to ensure that an adequate financial warranty is held to complete reclamation in total per the reclamation plan provided to the Division.

Please see the December 17, 2024 inspection report for details regarding why this surety increase is required.

On February 3, 2025, the Division ordered amendment of the current Financial Warranty or submittal of a new Financial Warranty reflecting the increase, within 60 days.

The Permittee for this site may be scheduled for a Formal Board Hearing for possible revocation of the permit if the amount of any increased Financial Warranty has not been provided by April 4, 2025.
