Hi Adam.

Just to clarify, you need to submit an updated reclamation map and reclamation plan. Once I receive the revisions, I will approve the technical revision to update the approved rec plan for the site. After that, you can submit a release request for the areas that haven't been used or worked in years, as long as those areas are fully reclaimed. I assume the main mining area isn't ready for release. The vegetation will need to fill and which typically takes two or more seasons.

Note, since the engineer is working on the maps, go ahead and have him prepare a separate map that outlines the areas you want to release and note the acres for each, and show what will remain in the permit area. You will submit this map with the release request.
