Mr. Absmeier:

The Division of Reclamation, Mining and Safety (Division/DRMS) received the above-referenced Technical Revision application on January 30, 2025. Based on review of the material submitted, the Division has identified the following item(s) must be addressed before the Technical Revision application can be approved. Please submit a cover letter responding to the item listed below.

1. The Operator provided a quote from a third-party contractor to treat the affected area with an herbicide. In accordance with Rule 3.1.10(6), please provide a revised Weed Management Plan to be followed for the life of the operation. This should include a monitoring plan, a list of potential weed species to be treated (the applicant could consult with Alamosa County on this list), treatment options (mechanical, chemical, and/or biological) and follow-up monitoring to evaluate the effectiveness of enacted weed control measures.

Please note the Division is required to issue a decision on the TR-3 application by **March 1, 2025**. If you cannot address the above issue before the decision date, please request an extension of the decision date to ensure adequate time for the Division to review material. If any adequacy issues remain by the decision date, the Division may deny your request.
