# **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report to illustrate some of the conditions observed.

The BLM Olathe Pit is located approximately 5.5 miles southwest of Olathe and accessed from H-54 Road. The site is a 110c operation that includes a total of 4.8 permitted acres.

Pursuant to Rule 4.1.2 (2), a financial warranty is not required for this site.

Adequate mine identification signage was bolted to a boulder at the entrance to the site.

The affected area was marked by a perimeter berm that was clearly visible and adequate to delineate the affected area boundary.

The site was inactive during this inspection. Signs of any recent activity were not evident. No equipment was stored on site.

Piles of stone and dirt are located randomly within the bermed area. No processed materials stockpiles were seen on site.

No problems related to disturbance of the prevailing hydrologic balance were noted. The operation has not exposed groundwater. Stormwater runoff is contained within the pit. The porous nature of the pit walls prevents ponding through infiltration.

There are no processing facilities on site, and thus no processing waste.

Fuels or toxic materials are not stored on site. Acid generating materials are not exposed by the mining operation.

No offsite damage was noted.

Explosives are not used for this mining operation.

Final reclamation has not yet commenced.

No problems or violations were noted during this inspection.
