Hi Jeff.

Please see the attached inspection report for the Gladstone Toll Mill. I apologize for the long turnaround time in getting this out to you. Please review the report and let me know if you have any questions on it.

One important issue for you to address that I didn't notice until I was looking at the photos for the report, the mine sign needs to be replaced. You still have the notice to sign up from the application process. Please replace the sign at the entrance with one that meets Rule 3.1.12. Once you put up the new sign, please email a photo of it in place to me.

Rule 3.1.12: At the entrance of the mine site the Operator shall post a sign, which shall be clearly visible from the access road, with a minimum size equaling one hundred and eighty-seven (187) square inches, such as eleven (11) inches in height and seventeen (17) inches in width, with appropriate font size, with the following:

- (a) the name of the Operator and the operation name;
- (b) a statement that a reclamation permit for the operation has been issued by the
- Colorado Mined Land Reclamation Board; and
- (c) the permit number.
