Some minor investigation of future prospect sides was conducted, particularly in the northwest corner of Royal Hawk and southwest center of Klondike. We anticipate opening two new prospects and reclaiming two prospects. Four authorized prospects remain on this permit. Close out of annual prospecting is 31 Oct 2024. No changes have been made to the map since there are no new disturbances.
