Mr. Bottini:

On September 5, 2024, the Division of Reclamation, Mining and Safety (Division/DRMS) performed a routine monitoring inspection of the Butcher Pit, M1995-060. As a result of the inspection, the Division cited a problem that had a corrective action due date of December 8, 2024. On December 31, 2024, the Division sent a Notice Past Due Letter regarding the corrective action. After communication with the Operator, the Division concurred that a second period of Temporary Cessation would not be necessary if the permit is in final reclamation. The Operator submitted on response on February 4, 2025 with a timeline to complete the reclamation tasks. The Division hereby notes that the reclamation timeline submitted by the Operator is appropriate and the corrective action has been resolved.
