All prospecting activities other than by hand sampling are done underground. This is done by driving the drift face forward and then sampling newly exposed rock wall. Rock removed from adit is used inside work area to level ground as per Plan of Operation. Buildings are temporary and are locked with hooded locks. Adit is blocked above by chain link fence and snow fencing and from below by chain link fence and straw catch fence. Work area and reclamation area are inspected by Ranger USFS, Dillon Ranger District 970-262-3448.
