RE: COMPLIANCE ADVISORY - TREATMENT OPERATOR CERTIFICATION INCORRECT CLASSIFICATION CROSS AND CARIBOU MINES, C00032751

To Whom It May Concern:

The Grand Island Resources LLC owns a wastewater treatment facility (facility) that is subject to the Colorado Discharge Permit System, Permit No. CO0032751 (permit). Pursuant to §25-9-110(2)(a), C.R.S., 5 CCR 1003-2, §100.10.1(a), and 5 CCR 1003-2, §100.10.5, no owner of an industrial wastewater treatment facility, domestic wastewater treatment facility, and/or wastewater collection system shall allow the facility to be operated without the direct supervision of an operator in responsible charge (ORC) certified at the appropriate level. Pursuant to 5 CCR 1003-2, §100.10.4, the owner of a wastewater facility is required to submit in writing to the Water Quality Control Division (division) the full legal name and operator identification number of the ORC(s) employed by the owner.

A review of division records indicates the ORC currently on file with the division does not hold a certification at the classification level required for the wastewater treatment facility. Please note, the criteria for treatment facility classifications were updated on March 1, 2019. As of March 1, 2021, all facilities, new and existing, are subject to the current classifications.

Failure to operate a wastewater treatment facility under the supervision of a certified ORC with a valid certification at the proper classification level constitutes violation(s) of §25-9-110(2)(a), C.R.S., 5 CCR 1003-2, §100.10.1(a), and 5 CCR 1003-2, §100.10.5.

To correct this violation, please use the attached Change of Contact form to document that the Grand Island Resources LLC wastewater treatment facility is being operated under the supervision of an ORC with a valid certification at the proper classification level. Required facility classifications are outlined in 5 CCR 1003-2, §100.5 for domestic wastewater treatment facilities and 5 CCR 1003-2, §100.7 for industrial wastewater treatment facilities.
