Hi Rick,

The Division received your photos of the reclamation that your team has done at the McKenna Limestone Quarry (no. M-2000-039) on March 25, 2025. The problem cited for "Reclamation has not been carried to completion within five years of last mining activity at the site as required by Rule 3.1.3." has been **abated**.

**Please provide evidence that the mine sign has been replaced, and that weed control has been conducted onsite, to abate the remaining inspection problems cited during the Division's 2024 inspection.**

Per our phone conversation, I have attached the link to the form you can use to request a surety reduction for the McKenna Limestone Quarry below. Please only check the box for Surety Reduction (see screenshot below). Please fill out the rest of the form and attach an additional page where you provide information about what reclamation has occurred onsite since the last inspection, and any additional photos you may wish to include. Upon receiving the application I will schedule an inspection to go out and document the reclamation progress, and I will re-calculate the remaining reclamation cost estimate.
