**Re: Immediate Preliminary Adequacy Review, Conversion Application (CN-1),  
Cross Gold Mine, Permit No. M-1977-410**

Mr. Mittasch:

On December 16, 2024, the Division of Reclamation, Mining and Safety (Division/DRMS) received the Conversion Application (CN-1) to convert the current 110(2) to a 112(d)-3 Designated Mining Operation for the Cross Gold Mine, File No. M-1977-410. On February 6, 2025, the Division determined the application complete for the purposes for filing and technical review could begin. The following item requires your immediate attention.

1. In the Division's Incompleteness Notice, dated December 26, 2024, the Division noted in item #6 that Grand Island Resources, LLC ("GIR") was no longer in good standing with the Colorado Secretary of State and was delinquent in its filings. In response, GIR provided a document that alleged they had obtained compliance with the Colorado Secretary of State and were now in good standing.

However, GIR is listed as a "Wyoming Foreign Limited Liability Company" with the Colorado Secretary of State. A review of the Wyoming Secretary of State's website shows that GIR is "Administratively Dissolved" (see Attachment 1 to this letter).

As such, GIR must provide to DRMS documentation from the State of Wyoming that GIR as an entity is currently registered and in Good Standing. The requested documentation needs to be provided to the Division by **April 21, 2025**.
