## PUBLIC NOTICE

Bowie Resources LLC, P.O. Box 483, Paonia, CO, 81424 has submitted an application for a partial Phase I bond release to the Division of Reclamation, Mining and Safety for its mining permit No. C-1996-083. The mining permit was initially approved on April 4, 1997 and renewed on April 4, 2022. Currently, the required reclamation security is \$11,448,977 and this surety bonds. This permit action will release approximately \$1,350,000 from the reclamation bond. The areas for which partial bond release is being requested is at Gob Piles #1, 2, 3, 4, Gob Vent Bore Holes 17C, 17D, 17E, 17F, Terror Creek fan site and other miscellaneous tasks.

This partial bond release will seek partial release (Phase I) of tasks associated with hauling gob out of the drying area at Gob Pile 3, spreading gob at Gob Pile 3, placing cover fill at Gob Piles 1, 2, 3, 4 and finish grading the Gob Piles. In addition, partial release will be sought for plugging and sealing gob vent bore holes 17C, 17D, 17E and 17F and partial release of plugging and backfilling the Terror Creek Shaft.

Reclamation activities at the Gob Piles has been an ongoing process and has involved removing waste from the drying area as well as re-configuring the existing piles to achieve final configuration as approved in the associated permit documents. The final configuration of gob pile #3 was achieved in 2022. The final configuration of a portion of gob pile #2 was achieved in 2015. Plugging and sealing of the gob vent bore holes was completed in 2023, plugging and sealing of the Terror Creek shaft was done during 2021. All reclamation activities were achieved in accordance with the approved permit documents.
