

The full distribed area of 0.1 acres was backfilled, graded, topsoiled and seeded in the Spring of 2023. We are waiting to see that the vegetation has taken. It will take additional time in such a dry area with very poor native topsoil. Additional vountary reclamation was also conducted, as shown on the NOI Reclamation Map. A recent site inspection was conducted by Gerald Korinek and it has shown that the site requires additinal time for vegetation to grow. This is normal for an area such as this.
