A Notice to conduct additional exploration was filed on or about 7/25/2023, which would increase the proposed surface disturbance over one acre. Application for NPDES storm water permit was filed with CDPHE to cover the increased acreage. That permit application is still pending.

No exploration or equipment movements have been conducted at the project since completion of three drill holes in August 2023. The drill sites were reclaimed immediately after drilling activities in July-August 2023 and storm water protection measures were put in place at that time.

During the period June 27 to July 3, 2024 reseeding of the affected area was undertaken by application of the West End Seed Mix and the storm water measures were reviewed for adequacy and effectiveness. The site was in good order, however minor improvements (additional wattles) were put in place to fortify previous measures. A current site review is scheduled to occur in the period April 25 to 27, 2025.
