Good morning, Kellie -

Please see the attached report from my inspection in November last year. I cited three problems. Two of them have been resolved, but the first one (General Compliance with Mine Plan) has not been resolved, and the current resolution date was yesterday. As the problem statement says, the mining schedule in Exhibit D should be updated to more accurately reflect the current conditions and plans for the site.

Please send an email (new one or response to this one) asking for an extension of the resolution date for this problem until June 13, 2025.

That will give Best Sand and Gravel a few weeks to submit a TR to update the currently approved mine plan to reflect existing and proposed activities at the site. Alternatively, if you guys are working on an amendment to the permit, and you plan to submit it in 2 - 3 months, then we can extend the resolution date again, as appropriate.

If you have any questions, let me know. This morning and early afternoon I will only be available sporadically; I need to drive to Eastern Colorado for an inspection.
