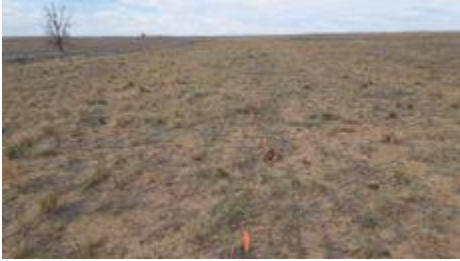

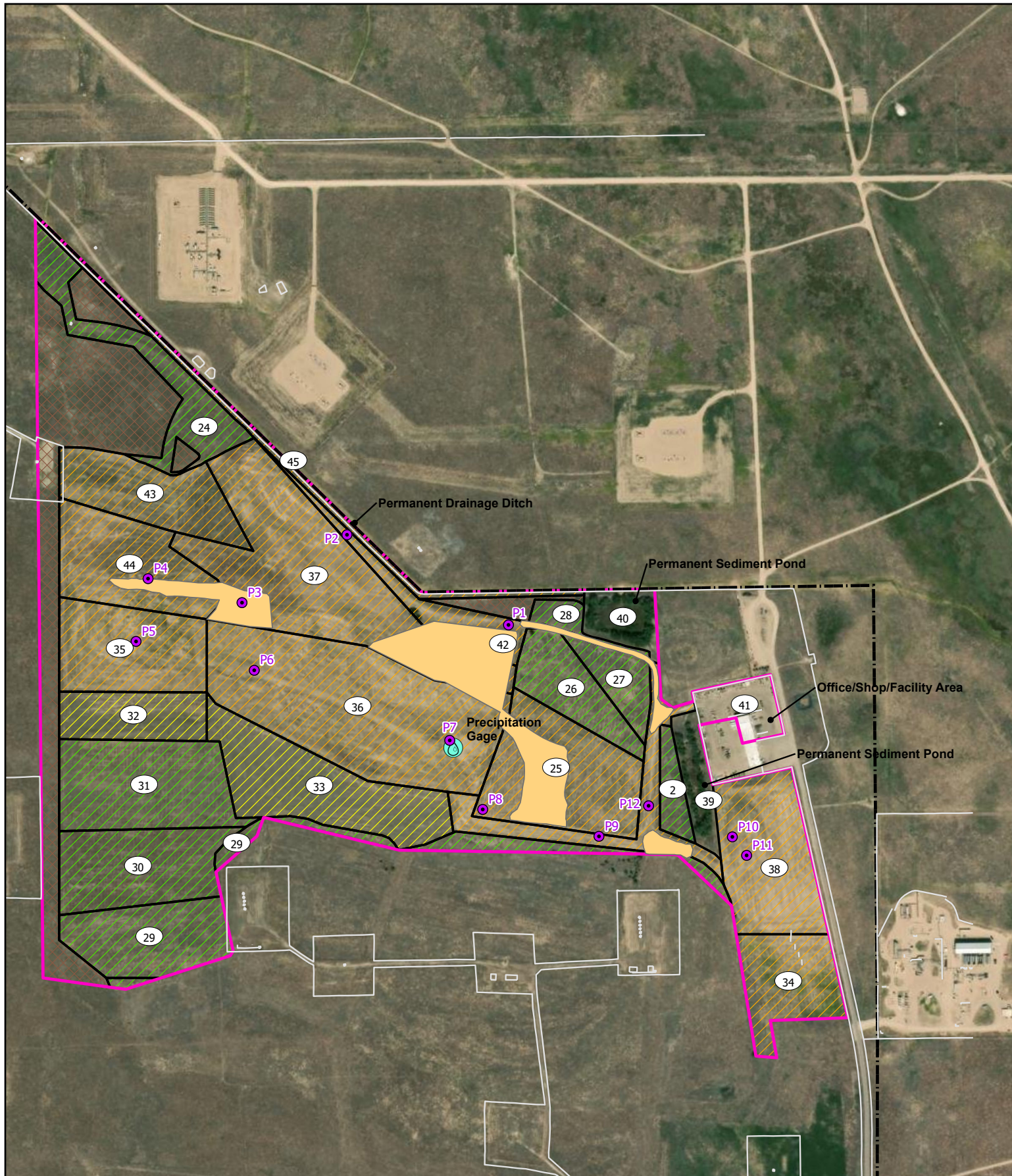


Area 28 and 34 2022 reclamation establishing well. No follow up work is required.
