Hi Nikie,

We have reviewed the report and do not have any concerns with the proposal to install a drain should groundwater drop to 3 feet below the ground surface. Additionally, should DWR become aware of any groundwater timing issues, additional mounding/shadowing issues affecting water rights or recharge, etc. due to the liner, we may ask them to install a drain if the water commissioner observes these issues.

I thought I would follow-up with you on the Ft. Lupton amendment application since you submitted a comment on sites with multiple liners. We asked the operator to provide a groundwater modeling report for the amendment area, which includes the adjacent slurry walls.

The model estimates a hydrologic change from the slurry walls of approximately 4 feet on the mounding/upgradient side and about 2 feet of shadowing downgradient. The operator committed to monitoring groundwater levels monthly. They are not proposing a french drain at this time, however, they committed to one if the exterior monitoring wells show the groundwater is approaching 3 feet below the ground surface.

The groundwater modeling report is attached. Let me know if you think their proposal is reasonable and if you have any additional comments for the operator. The decision date for this amendment is May 9.
