OBSERVATIONS

The Kinnie Gravel Pit was inspected by Joel Renfro with the Division of Reclamation, Mining and Safety on March 25, 2025 as a part of the Divisions regular monitoring program. Kacey Campbell and Bob Coty with Sedgwick County Road and Bridge were present during the inspection. The Kinnie Gravel Pit is located approximately 11 miles south of Julesburg, CO in Sedgwick County. The weather was clear at the time of inspection. **Photos 1-6** taken during the inspection are included with this report.

This is a 110c operation permitted for mining gravel. The permit area is 9.9 acres. The post-mine land use is rangeland. The site was inactive at the time of inspection. This site can be accessed from the north of County Road 12.

Permit boundary markers were observed during the inspection. There were metal posts with a tire on the bottom located in each corner of the permit area acting as boundary markers.

The gravel material is used in county road maintenance. Some material stockpiles were observed on the pit floor. Mined slopes surround the pit with some topsoil stockpiles located to the northwest of the pit.

It appears that this site may have had issues with water pooling in the pit, but the operator has dug out the pit floor and mitigated most of those issues. No water was observed in the pit floor during the inspection.
