During 2024-2025 reporting period, work conducted on the lands impacted by the P2021-010 permit consisted of preparing about 1870 feet of historic existing road for access to historic drill pads. Management decided not to drill the holes, so the roads were reclaimed and reseeded. No final abandonment forms were submitted since there was no drilling.
