During the 2024-2025 reporting period, work conducted on the lands covered by the 2021-008 permit consisted of preparing pads and access roads for the drilling of nine reverse circulation drill holes. Four of the nine holes were angle drill holes drilled off of one pad to minimize surface disturbance. Access to the holes utilized a combination of historic roads, newly constructed roads and cross-country routes. All holes were abandoned as per State statutes. Reclamation used Best Management Practices.
