On May 14, 2025, the Colorado Division of Reclamation, Mining and Safety (the Division) received your Annual Reclamation Report Adequacy Review Response. The Division finds the report in compliance with the following Rules:

2.04.13(1) – The 2023 and 2024 ARRs were received by the Division on February 29, 2024, and February 13, 2025, respectively.

2.04.13(1)(a) – The cover of the ARRs include the name of the permittee, the address and the permit number.

2.04.13(1)(b) – The reports listed 31.0 and 24.7 acres of new disturbance during the calendar year of 2023 and 2024, respectively.

2.04.13(1)(c) – The reports listed that 21.0 and 30.3 acres were backfilled and graded in 2023 and 2024, respectively.

2.04.13(1)(d) – The reports listed 54.1 and 41.7 acres that were topsoiled in 2023 and 2024, respectively.

2.04.13(1)(e) – The reports listed 0.0 and 10.9 acres that were seeded during 2023 and 2024, respectively.

2.04.13(1)(f) – The reports listed total acreage that has been previously seeded. The ARR Maps document the location and date of planting for all previously revegetated areas.

2.04.13(2) – Additional documentation provided with the 2023 and 2024 ARR included a map showing the record of reclamation activities at the Colowyo Coal Mine.
