Hi Mike,

Thanks for sending this along. The Colorado State NOI is received by our office.

Please revise the dates and any other pertinent information on the Forest Service Notice of Intent (attached) and submit that to my office prior to commencing prospecting activities. The October 2024 NOI described activities through November 2024, we request revised submittals for each calendar year of work.

In reading through your activities, I would like to re-iterate that any motorized use of the closed road with UTVs, 4WD vehicle vehicles, etc. requires the Forest Service to complete a NEPA analysis and decision. This can be time consuming because of the workload on our specialists, so I encourage you to submit an MPO the season prior to your intended motorized access to the Crystal Victoria site so that we can schedule and begin work on the required environmental analysis and public comment period.
