On May 22nd, 2025, the Colorado Division of Reclamation, Mining and Safety (“DRMS” or “Division”) received a Notice of Intent to Conduct Prospecting Operations for Hard Rock/Metal Mines (“NOI”) form. Our initial review of the NOI indicates that, as of May 30, 2025, you have satisfied the minimum requirements of the Act and the Rules to begin the review process. The Division has begun the technical review process.

Pursuant to Rule 5.1.3(a) of the Hard Rock/Metal Mining Rules and Regulations, the Division will conduct an in-depth review of your notice. You will receive notice of any deficiencies or requests for additional information from the Division within twenty (20) working days, on or before June 20, 2025. The Division will also notify you, within twenty (20) days, if the review indicates the proposed operations are considered to be mining, rather than exploration of prospecting.

A Financial Warranty has been received in the amount of (\$2,000.00) and is currently under review by the Division.
