Subject: Land Use Change Permit Requirements for Gravel Pit Operations at 5400 County Road 76

Hello John,

Thank you for your patience – I was in an all-day meeting yesterday.

I am writing regarding your interest in restarting gravel pit operations at <u>5400 County Road</u> <u>76</u> for the sale of materials for construction and landscaping use.

I want to make you aware of the applicable requirements under the Gunnison County <u>Land Use Resolution</u> (LUR). Per Division 9-400:B, any applicant proposing the exploration, mining, or processing of construction materials – including gravel – must obtain a Land Use Change Permit. This permit will be classified as a Major Impact Project because of the scope of the operation.

Based on your stated intent, your proposal will qualify as a Major Impact Project under Section 7-101:E, which requires this classification of large construction materials operations that:

- 1. Operate more than 180 days per year,
- 2. Produce more than 10,000 tons of material per year, or
- 3. Disturb more than two surface acres of land.

We encourage you to review your operational plans, particularly your estimated days of operation, production volumes, and total area of disturbance and provide those along with your Major Impact Application.
