On June 17, 2025 the Division of Reclamation, Mining and Safety concluded its review of the Surety Reduction Request application submitted to the Division on April 24, 2025, addressing the following:

Surety Reduction requested following the issuance of SI1, highlighting the reclamation work that has been recently conducted at the McKenna Limestone Quarry.

The decision reached by the Division is: Approve. In accordance with Rule 4.17.2(5), the Division is required to wait thirty (30) days from this notice to allow for appeal of the Division's decision. Once this period closes, if no appeal is submitted, the Division's decision will be final.

This is a reduction of (\$15,228.00). This decision reduces the amount of the financial warranty, and does not approve any release of reclamation responsibility for the tasks associated with this request.
