Dear Mr. Tennyson,

We have received your application for a minor revision to your permit to conduct coal mining in Colorado. Our initial review indicates that all preliminary items required by Rule 2.08.4(5) have not been submitted. Thus, your application is incomplete for the purposes of filing as of June 18, 2025.

- 1. The change sheet lists 'South Taylor/Lower Wilson viii and ix (2 pages)' as pages to be removed and added back into the permit file. However, updated 'South Taylor/Lower Wilson viii and ix' pages were not included with Colowyo's MR264 submission. If changes were made to these pages, please provide the corrected pages to the Division to be included with other replacement pages.
- Item No. 30 states that Vol. 15 Rule 2, page 69 has been updated with corrected citations. However, an updated Vol. 15 Rule 2, page 69 was not included with Colowyo's MR264 submission or listed on the change sheet. Please provide the Division with the corrected page 69 to be included in the replacement pages.
