Request for Extension of Preliminary Adequacy Review, 112c Construction MaterialsRe: Amendment Application (AM-1), Kirtright Pit, Permit No. M-1986-123

Dear Mined Land Reclamation Board:

I am writing on behalf of Coulson Excavating Company, Inc. ("Coulson") regarding the above-referenced application (the "Amendment Application"). Kaplan Kirsch LLP ("Kaplan Kirsch") is assisting Coulson in updating the Amendment Application and in responding to the Adequacy Review letters provided by the Division of Reclamation, Mining and Safety ("DRMS") in connection with the Amendment Application (the "Adequacy Review Letters"). Coulson has been coordinating with DRMS to ensure that the Amendment Application properly addresses all items raised by DRMS in the Adequacy Review Letters.

DRMS recently asked Coulson to prepare hydrologic modeling of a portion of the affected lands subject to the Amendment Application. Coulson is prepared to do so; however, the need for this modeling is a serious unforeseen circumstance that Coulson will not be able to address prior to the current decision date of June 11, 2025. Coulson will need to obtain certain data from the Colorado Department of Transportation and engage an additional engineering consultant to assist in preparing HEC-RAS (Hydrologic Engineering Center - River Analysis System) modeling. Accordingly, Patrick Lennberg of DRMS has suggested that Coulson request a sixty day extension of the decision date.

Pursuant to this letter, Coulson requests that the June 11, 2025 decision date be extended by sixty days to August 10, 2025. This request is in keeping with Rule 1.4.1(7) of the Mineral

Rules and Regulations of the Colorado Mined Land Reclamation Board, which provides that "[i]n the case of any complex Permit applications, serious unforeseen circumstances or significant snow over on the affected land that prevents a necessary on-site inspection, the decision date established by the Office may be extended up to sixty (60) days beyond the usual maximum limit for an operation of that particular typer and size."
