The Trapper Mine is a/an surface operation located in Moffat County, approximately 6 miles Southwest of Craig, Colorado. Coal interest is federal, state and private, and the surface to be affected is state and private land. The permit area encompasses approximately 11,293.79 acres. This proposed decision is based on a finding of whether the proposed operation will comply with all requirements of the Colorado Surface Coal Mining Reclamation Act, Section 3433101, et seq., C.R.S., and the regulations promulgated thereunder.
