Dear Mr. Bottini:

On April 23, 2025, the Division of Reclamation, Mining and Safety (“Division” or “DRMS”) performed a routine monitoring inspection of the Costilla Pit, permit number M-1987-040. As a result of the inspection, the Division cited problems that require corrective action and must be addressed by June 27, 2025. In addition, the Division noted that the reclamation liability for the site increased, and a cost estimate was provided with the inspection report. The Operator has requested a 90-day extension to complete corrective actions due to an incoming Succession of Operator submittal. The Division hereby provides approval for an extension of 90 days. The new corrective action due date is **September 25, 2025**.

Please note that if the corrective actions are not properly addressed, and evidence provided to the Division by the date provided above, the listed problem could be escalated to the level of possible violation and referred to the Mined Land Reclamation Board for further action.
