Dear Mr. Bottini:

On April 23, 2025, the Division of Reclamation, Mining and Safety ("Division" or "DRMS") performed a routine monitoring inspection of the Southway Pit, permit number M-1981-153. As a result of the inspection, the Division cited a problem that requires corrective action that must be addressed by June 27, 2025. The Operator has requested a 90-day extension to complete the corrective action due to an incoming Succession of Operator submittal. The Division hereby provides approval for an extension of 90 days. The new corrective action due date is **September 25, 2025**.

Please note that if the corrective actions are not properly addressed, and evidence provided to the Division by the date provided above, the listed problem could be escalated to the level of possible violation and referred to the Mined Land Reclamation Board for further action.
