Prospecting activity in the 2024 mining season includes Four total pits mined and reclaimed, One pit mined on Site 1, Three pits mined and reclaimed on Site 2. The Two mine sites were monitored and maintained to protect the wildlife and grazing cows.

The ponds and wash plant are closed circuit systems. The ponds and wash plant are fenced in to protect the wildlife and grazing cows. The fence is temporary and can be removed quickly. No new roads or structure were added to the mine site. All driving was done on existing 2 track.
