Hi Jason,

Thank you for sending those documents over.

For the Inspection Problem #1 (Right of Entry) Corrective Action, we will need updated documentation that is between General Shale Brick, Inc. and the current landowner. The provided lease has the permittee name as Robinson Brick Company, which is no longer valid. This documentation does not need to be a lease, but you can send a notarized letter agreement from the current landowner giving General Shale Brick, Inc. right of entry onto the property. I am happy to extend this due date by 90 days.

For the Inspection Problem #2 Corrective Action due date extension request, the Division is willing to extend the date out by 90 days. This can be extended once we get closer to the 90 day extended due date, but we won't be able to extend the date out to December 31, 2025 at this time.
