RE: Two Rivers, Permit No. M-1998-038. Application for Succession of Operator (SO-2); Incompleteness Notice

Dear Mr. Majka and Mr. Ary,

On July 3, 2025, the Division of Reclamation, Mining, and Safety (Division/DRMS) received the Request for Transfer of Mineral Permit and Succession of Operators application packet (SO-2) for Two Rivers, Permit No. M-1998-038, located in Pueblo County. A review of the information received determined the following items must be received/corrected before the Division can consider the application complete and filed.

Application Form:

1. On page 5, under Administrative Information, Prospective Successor Information, the address provided for Oldcastle SW Group, Inc. dba United Companies is 839 Mackenzie Avenue, Canon City, CO 81212. According to the Colorado Secretary of State, a different address is registered for Oldcastle SW Group, Inc. Please make the appropriate corrections.

Right of Entry:

- 2. The lease agreement between Oldcastle SW Group, Inc. and Preferred Materials, Inc., provided in the application package, is not completely executed, with only the first page of the agreement provided and the signature page excluded. Please provide the complete lease agreement between the parties to include the signature page(s).
- 3. The affected lands of the permit includes Parcel No. 11-170-00-022. According to the Pueblo County Clerk and Records, this parcel is owned by Fremont Paving and Redi Mix Inc. Please provide documentation to show Oldcastle SW Group, Inc. dba United Companies' legal right of entry on all the affected lands of the permit.

Structure Agreements:

- 4. Several of the Structure Agreements included in the application package were not signed by the owners. Please submit fully executed Structure Agreements for the following owners and structures:
 - a. Anthony Gonzales; Home and Outbuildings
 - b. Black Hills Energy; Powerlines
 - c. Century Link; Pedestal and Underground phone lines
 - d. Colorado State Land Board; Fence
 - e. High Line Canal; Canal and Fence
 - f. Dennis Pritchard; Fence
 - g. Dos Rios Ranch c/o Donny Talton; Fence
 - h. Dos Rios Ranch c/o Filadelfio Rael, Jr; Fence
 - i. Gary Fillmore; Well and Water Line
 - j. Jose Gonzales; Fence, Barn and Animal Sheds
 - k. Kent Ricken; Fence
 - 1. Michael Romero; Fence
 - m. Orchard Park; Water Hydrant and Water Line
 - n. Posada; Fence
 - o. Pueblo County; County Roads 57th and 58th
 - p. Valerie Harris; Fence
 - i. Note that per Rule 6.4.19(c), where the structure is a utility, the applicant may supply a notarized letter, on utility letterhead, from the owner(s) of the utility that the mining and reclamation activities, as proposed, will have "no negative effect" on their utility. This may be applicable for structures owned by Black Hills Energy and Century Link.
- 5. The Geotechnical Stability Exhibit submitted with the application packet states "... buildings or other structures within 200' of the Two Rivers Pit affected area will not be affected by mining excavation." Rule 6.4.19(b) does allow for the use of an engineering evaluation stating that such structure shall not be damaged by mining activities in the case that an agreement as outlined in Rule 6,4,19(a) cannot be reached by the applicant with an owner(s). If the geotechnical evaluation is intended to be used as such an engineer evaluation for those structures where agreements could not be reached, then it should explicitly address the structures, and the recorded owner of said structures, for which Oldcastle SW Group, Inc. dba United Companies was not able to obtain a structure agreement. The geotechnical evaluation must also demonstrate that the structures will not be affected by mining and reclamation activities.
