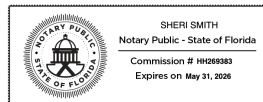

Seneca Property, LLC, 29515 Routt County Road 27, Oak Creek, Colorado 80467, is requesting approval of Technical Revision 54 filed with the Colorado Division of Reclamation, Mining, & Safety, to reduce ground water monitoring to allow for appropriate well abandonment for final release at the Seneca Yoast Mine (CDRMS Permit No. C 1994-082, approved August 5, 1995).
