During the preceding year, prospecting activity under NOI P-2023-014 included the excavation of 11 test pits, each measuring approximately 14 feet by 20 feet, and the drilling of 13 exploration holes, each within a disturbed area of approximately 12 feet by 12 feet. These activities resulted in an estimated total surface disturbance of approximately 0.26 acres.

All exploration occurred within the pre-approved 4-acre disturbance area. No new roads, mud pits, rock dumps, adits, shafts, trenches, or structures were constructed. All activities were conducted using low-impact methods, and no sumps or drill fluid pits were required.

Upon completion of each test pit or drill hole, the openings were backfilled or otherwise stabilized to ensure site safety and compliance. No vertical shafts or horizontal adits were created; therefore, no additional safeguarding measures were necessary for mine openings.
