## **Exhibit C**

1. Per 6.2.1(2)(b) & 6.2.1(2)(c) maps must be signed by a qualified person and dated. Please sign and date Exhibits C-1, C-3, C-4 & C-5.

Response: Maps C1-5 and F1 have been signed and dated by Dillon Foster, P.E., with River City Consultants. Please see the updated submittal package for Review 2.

2. Per 6.4.3(b) the names of all roads within 200 ft must be provided. Exhibits C-1 and C-4 show a road to the north of the pad where the access road originates. Please provide the name of this road.

Response: This has been discussed and decided upon to label the adjacent roads as 'Private Access Roads' due to the roads not being public or having official names. Both sheets C1 and C4 are updated. Please see the updated submittal package for Review 2.

3. Per 6.4.4(f)(ii) please identify the stratum immediately beneath the material
