No new prospecting holes were made more than one foot deep to examine pegmatites and pegmatite strikes. No material was removed. There are numerous hand-digs throughout all of our claims but only one is of significance. We fill them, recontour, and reseed if within a short distance of a machine whenever we come across any. One rogue miner is near Old Man rock but we have not yet taken a machine there to fill the unauthorized hole.
