Mr. Trujillo,

Here are some pictures of the wind blowing the dirt and noxious weed seeds onto my land on Saturday August 2, 2025, and pictures taken today August 4, 2025 from the same vantage points for comparison. In some pictures you can see they are cuttting over a foot deep. I have videos but was unable to upload them.

The "Is It Mining?" questionnaire they filled out, indicates they would be using a skid steer, mini ex and water truck. As you can see in the pictures, an 821G Case Loader with a 4 yard bucket is being used. I also question their assertion that this activity is "purely agricultural grading, intended to remove excess sand and improve the overall soil condition for farming conditions." Jerry Craig farmed that land for years and was a good steward to the land. Sandy soil is good for dry land farming. Do you really believe they will "import more suitable soil to improve agricultural conditions for crop production? The cost would be prohibitive. I would also like to know what "approved fill locations for disposal" means and where are they located?

Another thing, there is no erosion control on the property.
