The development of the Belle Creole Adit into a fire cistern has been completed. That area is in final reclamation and has been inspected previously. We overseeded the area above the portal to increase the vegetation density and plan on some additional overseeding this fall in a few areas that don't have great success.

The access trail north of Crazy Spring Trail on the maps will be developed in the next year. Once access is established to the portal of the Cray Girl Tunnel it will be evaluated to provide access and safe guarding.
