### **OBSERVATIONS**

This inspection was conducted by Brock Bowles of the Division of Reclamation, Mining and Safety (Division). John Lee and Amy Titterington of the USFS and Randy Stone of the Iowa Mill (operator) were present for the inspection. The weather during the inspection was clear and warm. The ground was dry.

The NOI consist of two non-contiguous sites: The Iowa Mill is the lower site, and the Carbonate Mine is 1/2 mile directly uphill from the mill slightly above tree line. Both sites have a combined footprint of 0.9 acres. The Little Tommy Mine is located between the two sites and is also operated by the Iowa Milling Corp., but is a separate NOI, P-2007-007. All the sites are connected by a USFS dirt road.

#### Hydrologic Balance:

The soil around the mill building was stable and no erosion features were noted (photo 1). The pad area and out slope area around the Carbonate Mine was stable and well vegetated. No erosion features were seen. No water or evidence of erosion was seen coming from the mine portal. Very little prospecting activity appears to have taken place recently.

#### Financial Warranty:

DRMS hold a \$2,000 bond for the reclamation of the site. The bond does not include removing any of the historical buildings at this time.

# Gen. Compliance With Mine Plan:

At the time of this inspection, maintenance was being performed on the Mill building. No tailings or ore were being processed or stored at the mill site (photo 2). The mill building is located very close to the USFS road which had a surprising amount of vehicle and hiker activity.

The Carbonate Mine site consists of a metal shed (photo 3), a secured steel portal and an old wooden loadout chute. The loadout chute is not operational but is being considered for historical preservation.
