RE: Permit No. M-1980-244; Cripple Creek & Victor Gold Mining Company ("CC&V"); Cresson Project – Notification of Water Quality Analysis September 4, 2025.

Dear Patrick,

The Cripple Creek and Victor Gold Mining Company (CC&V) hereby provides the Division of Reclamation, Mining, and Safety (Division) with a formal notification of water quality analytical results for wells CRMW-3B, CRMW-3C, CRMW-5B, CRMW-5C, and CRMW-5D. As per the Stipulated Agreement with DRMS dated April 25, 2024, CC&V is in the process of establishing appropriate site-specific groundwater standards with the Water Quality Control Division and Water Quality Control Commission. However, notwithstanding this uncertainty, CC&V is providing this notice within the time allowed by Rule 3, Section 3.1.7 (9) of the Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board for Hard Rock, Metal, and Designated Mining Operations.

CC&V collected Q3 2025 groundwater compliance samples from monitoring wells CRMW-3B and CRMW-3C on August 13, 2025, and monitoring wells CRMW-5B, CRMW-5C, and CRMW-5D on August 18, 2025.

Analyte concentrations over time are included as Attachment 1. Table 1 below lists results compared to the previously set NPLs and Table Value Standard.

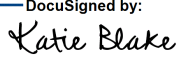
