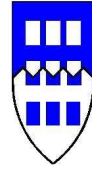

Dear Mr. Girardi:

As discussed, we request an extension to next Friday, 19 September 2025, for the final decision date to allow us to obtain either a receipt or an affidavit for depositing the most recent changes to the application package with the Archuleta County Clerk and Recorder.

As stated, we sent an electronic copy of the changes for the Clerk to print and post with the review/display copy but have not received a receipt. We can state that we have provided that to the Clerk and Recorder for display at their new address of 305 Village Drive (actually west of Pagosa Springs in the Pagosa Lakes area), if you consider this letter to be an adequate affidavit as signed below. However, in following up today, we discovered that the Clerk and Recorder's Office is now closed regularly on Friday so could not confirm that they actually have printed out and put the additional information in the copy which has been on display.

As given in a separate email, we have reviewed and request changes in the reclamation cost estimate, and await your review and decision on that. When that amount is finalized, the Financial Warranty will probably be provided as a rider on the current Warranty of \$5,452.00, to be coordinate and sent to Sara in Denver.

We do need to clarify if a new Performance Warranty needs to be executed, or if the current one continues in effect.

Thank you for this letter. Please let me know if this needs to be posted on the ePermitting portal.
