On September 4, 2025, the Division of Reclamation, Mining and Safety (“Division” or “DRMS”) received the Technical Revision (TR-2) application for the Alamosa Pit No.2, permit number M-1983-175. Based on review of the material submitted, the Division has identified the following items must be addressed before the TR-2 application can be approved. Please submit a cover letter responding to the item listed below.

1. Please fill out the attached Request for Technical Revision Importation of Inert Fill form or clarify the details of the inert backfill material pursuant to Rule 3.1.5(9).
2. Please revise the site map to meet the requirements of Rule 6.2.1(2).
3. For the attached site map, please include the location(s) within the permit area of where imported backfill material will be temporarily stored, or clarify otherwise.
4. Please clarify why the open groundwater pond located in the northwest corner of the permit area did not have a red arrow, indicating it will not be backfilled.

Please note the Division is required to issue a decision regarding the TR-2 application by **October 4, 2025**. If you cannot address the above issue before the decision date, please request an extension of the decision date to ensure adequate time for the Division to review material. If any adequacy issues remain by the decision date, the Division may deny your request.
