OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining and Safety (Division) normal monitoring program The Johnson Draw is a 112c permitted site that includes a total of 40 permitted acres. The site is located two miles west of Rangely, Colorado and is accessed from County Road 2. The pit is on property owned by the State Land Board. Clint Chappell represented the operator and accompanied Amy Yeldell of the Division on the inspection. No financial warranty is held for this site as is it operated by Rio Blanco County, per Rule 4.1.2(2).

A mine sign was posted at the entrance to the mine site as required by Rule 3.1.12(1). The information depicted was correct/up to date and the sign was of sufficient size. The permit boundary of the affected land was clearly delineated pursuant to Rule 3.1.12(2).

This pit is approaching the conclusion of mining. Most of the perimeter has been graded. Some additional materials may be removed if not necessary for contouring. Additionally, the powerline along the south side of the site still has bank material. This material will likely be left as it is rather than coordinating the utility pole relocation. There is a stockpile of pit run on site. The county is debating if they wish to haul it off site to West Johnson Draw or bring in the crusher to process the remaining amount. Once this stockpile is removed final reclamation can commence. Some areas have begun to self-reclaim.

A dozer was located on site to complete grading tasks. No fuel was present. Overall, the site is kept in good working order. Stormwater controls are properly employed with no signs of erosion. Little to no weeds were observed. Native vegetation has volunteered in some areas. No problems or violations were noted during this inspection.
