Resolution:

Colorado Stone Quarries, Inc. is requesting that the Mined Land Reclamation Board (Board) grant an extension of a corrective action date. The request is due to design difficulties with meshing Colorado Stone's future mining plans and sedimentation control designs with location and topography of the site. The corrective action, ordered by in the Board Order signed November 13, 2009 requires Colorado Stone to provide all materials necessary to allow Division approval of a technical revision or amendment of the reclamation permit addressing sedimentation control plans, including structural designs, construction details, a schedule of compliance and, if necessary, engineer certifications for designs by April 30, 2010. The proposed activities delineated in the technical revision or amendment must be completed by August, 31, 2010.

DRMS supports Colorado Stone's request and recommends that the Board approve an extension of the corrective action due date from April 30, 2010 to June 1, 2010. Board approval of this Consent Agenda item will implement this recommendation.

Please note that this extension of the permitting portion of the corrective action does not extend the construction deadline. Implementation of final approved plans delineated in the technical revision or amendment must still be completed by August 31, 2010.

CHRONOLOGY

November 13, 2009: As a corrective action for Violation MV-2009-023, the Board ordered Colorado Stone to provide all materials necessary to allow Division approval of a technical revision or amendment to the reclamation permit, addressing sedimentation control plans, by April 30, 2010.

April 8, 2010: Colorado Stone Quarries request an extension to the April 30, 2010 compliance date.

April 9, 2010: DRMS indicates staff will support an extension of the due date, for the permitting portion of the corrective action only, to June 1, 2010.

Although Colorado Stone Quarries closed operations in January 2010, we have been actively working to provide all materials necessary to allow Division approval of a technical revision of the reclamation permit and of an amendment to Permit #M-1999-058.

Partnering with our engineering firm, we have completed field data collection and surveying, and have prepared a base map of existing conditions which is utilized in engineering studies. We are currently working on incorporating all land affected by our mining operations. In the meantime, we have also received the first engineering report and sets of drawings regarding a possible integrated Sedimentation Control Plan. Unfortunately, this technical solution does not fit Colorado Stone Quarries' future production planning, and does not allow for long-term development of the area. We would like to take additional time to explore further alternatives while keeping in mind that the deadline for board approval is April 30, 2010. Therefore, this is a written request for an extension in an effort to deliver a solution which will be more adequate and valuable for the environment as well as our future operations.

Please be assured that we are more than willing to address these issues as quickly as possible.
